ENTRY REQUIREMENTS

ENTRY DEADLINE is Monday, June 14, 2021

- All entrants MUST BE currently enrolled in a NEW YORK CITY SCHOOL
- Students currently in 3rd 12th grades are eligible to compete
- All players must have a USTA account or membership. That # is required on the application.
 If you do not have one, it is free to enroll on the playtennis.usta.com website.
- Each partner in Doubles must submit their own application
- Each player is responsible to check the web site for match times. Players will NOT be notified via email of their match times. Match times are on a "to follow" basis, and matches may be delayed from the designated time due to the previous matches on court running long. Match times will be posted on:

COVID Protocols

- All Mayor's cup participants are limited to two guests.
- All players, when not on court, and all tournament guests, must wear a mask. Remember that our participants are all juniors who are not able to be vaccinated. Please take care to keep them safe by wearing a mask when in the tournament area.
- Spectators must practice physical distancing unless they are with members of their household or close social contacts.
- All players and guests must complete a health questionnaire, which will be available at the check-in desk, on-line before their match
 to print out, or electronically on the check-in app. It must be completed and dated the day of the match. All participants and their
 guests will submit to a temperature check. An answer of "yes" to any of the mandatory health screening questions, or a fever,
 will result in that player or guest not being permitted to participate or spectate.

TOURNAMENT RULES

- Players or parents are responsible for checking their match time 24 hours in advance at nyitl.org /mayors-cup or
 playtennis.usta.com/tournaments (search by zip code or name). For your convenience, some match DATES are posted 48 hours in
 advance, but the actual match TIME is subject to change. It is important to check the website regularly.
- Format of play is 2 out of 3 tiebreak sets NO-Ad scoring all levels
- Coaching, verbal or by hand signals of any kind, will not be allowed except during the ten-minute break before a third set.
- Players may be scheduled to play two matches in one day, with 30-60 minutes rest between matches. A player should notify the tournament if they have played in another tournament in the area that day, as they will not be required to play three matches in one day.
- Roving officials will be on site at all times during the tournament to enforce the rules of tennis. Officials will have the authority to
 monitor matches, call foot faults, and settle disputes.
- The roving umpire will be the first in command to issue a point penalty. If a chair or roving umpire is unavailable or fails to assess the violation, the referee, tournament director, or designated assistant can issue point penalties. Flagrant unsportsmanlike conduct may result in an immediate default.

Point Penalty System: 1st Offense: Point, 2nd Offense: Game, 3rd Offense: Default

- A player is responsible for checking into the tournament desk or by electronic check-in at least 15 minutes prior to the start of his/her
 match time. Default time is 30 minutes from the posted time or when the match is called (if later than the posted match time.) However, the tournament director or designee may utilize his/her discretion in issuing a default for lateness.
- In cases of rain, players should call the site to determine if matches are on. Do not come to the site otherwise. Space is very limited to wait because of COVID protocols.

By Car: Directions from Manhattan: Cross Bronx (95 North). Exit at Webster Avenue, at stop light make right. Go to Claremont Parkway and turn left, (enter park). Go to Crotona Avenue and turn left. Courts are one block ahead on right. From Queens and Long Island: Cross Bronx (95 South). Exit at Third Avenue, at stop light make left. Go to Claremont Parkway and turn left, continue into park and turn left on Crotona Avenue. Courts are one block ahead on right.

Mass Transit: 1) From Manhattan or Queens—Subway & Bus to the door: #2 or #5 train to the Prospect Ave. stop. Transfer to a north-bound No.17 bus on Prospect Ave. which stops in front of the tennis courts in Crotona Park.

2) Subway & Walk: #2 or #5 train to 174th Street. Walk across Southern Boulevard, go up the hill at Crotona Park, and across the park to the courts and the Center.
