2025 US Open Championship Tickets to Benefit NYJTL
UPDATED SCHEDULE: Sunday August 24 – Sunday September 7

Dear Friend of NYJTL:

Thank you for your past support of the US Open Ticket Benefit for New York Junior Tennis & Learning. All of the net proceeds will support community tennis programs and comprehensive after school programs that incorporate tennis, academic enrichment, healthy living and character development for thousands of inner-city youths. We want to thank and acknowledge the USTA for allowing us the privilege of using US Open tickets to raise these much-needed funds.

This is our second letter in regard to the 2025 US Open Ticket Benefit for New York Junior Tennis & Learning, the first having been dated December 18, 2024.

On January 29, 2025, the USTA announced the 2025 US Open schedule and subscriber renewal pricing. Based on this information, NYJTL has revised its preliminary pricing and tournament schedule. The revised information includes:

- A) The updated schedule indicates two additional sessions. The US Open is now starting a day earlier with Opening Day, session [1], on Sunday, August 24, and session [2], Opening Night, on Sunday August 24 evening. The men's and women's singles first rounds will be played Sunday to Tuesday. No further adjustments to the singles main draw schedule after the first round are planned. The added day is for all three stadiums – Ashe, Armstrong and the Grandstand.
- B) Increases in Ashe Courtside pricing in the 3% - 5% range for most sessions as well as adding appropriate pricing for the 2 new sessions.
- C) All other prices (Loges and Promenades in Ashe Stadium and Courtsides in Armstrong and Grandstand Stadiums) will remain the same.

Also please note:

- 1. **We now have more options for seats, i.e., ADA Courtside seats, available in the Armstrong stadium.**
- 2. Please take note: Once again, there will be only mobile tickets this year. Our staff are prepared to assist you in this process.
- 3. The terminology for seats in Ashe Stadium in order of distance from the court is as follows: courtside boxes, luxury suites, loge boxes, and promenade seats. In the Armstrong and Grandstand Stadiums, all of our seats are in the reserved Courtside box category.
- 4. We continue to offer rain insurance for tickets in the Grandstand Stadium **since NYJTL does not take these risks**, and the donor does. The current USTA inclement weather policy is not being offered for Arthur Ashe or Louis Armstrong tickets.
- 5. The difference between NYJTL's cost of the ticket and our price is a charitable contribution to NYJTL.

We are greatly appreciative of your support. NYJTL is the largest local nonprofit organization dedicated to tennis and learning in the United States, offering comprehensive school and community programs throughout New York City for more than 85,000 children each year. 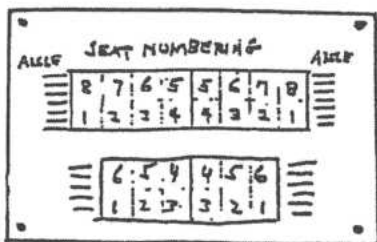
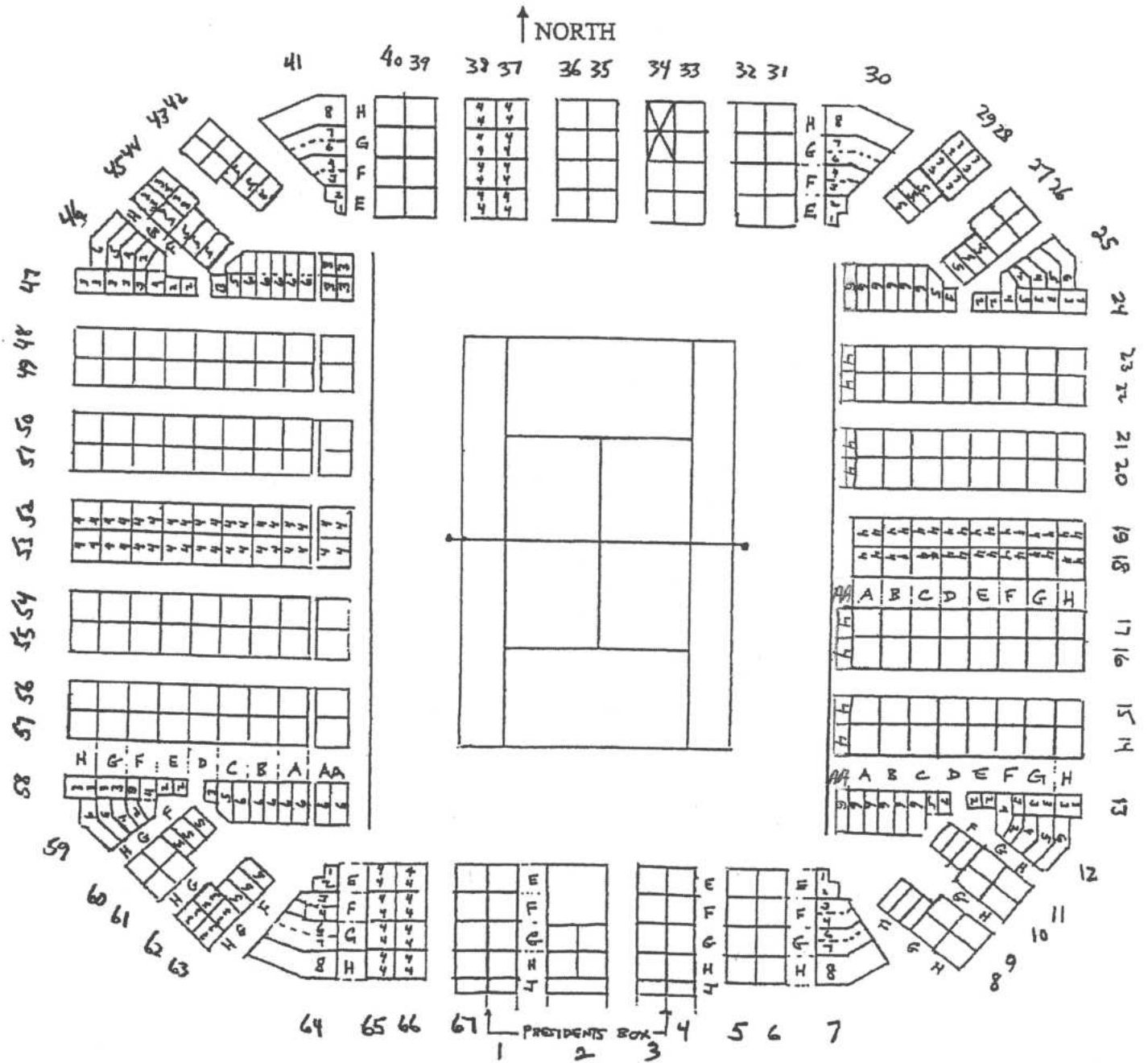

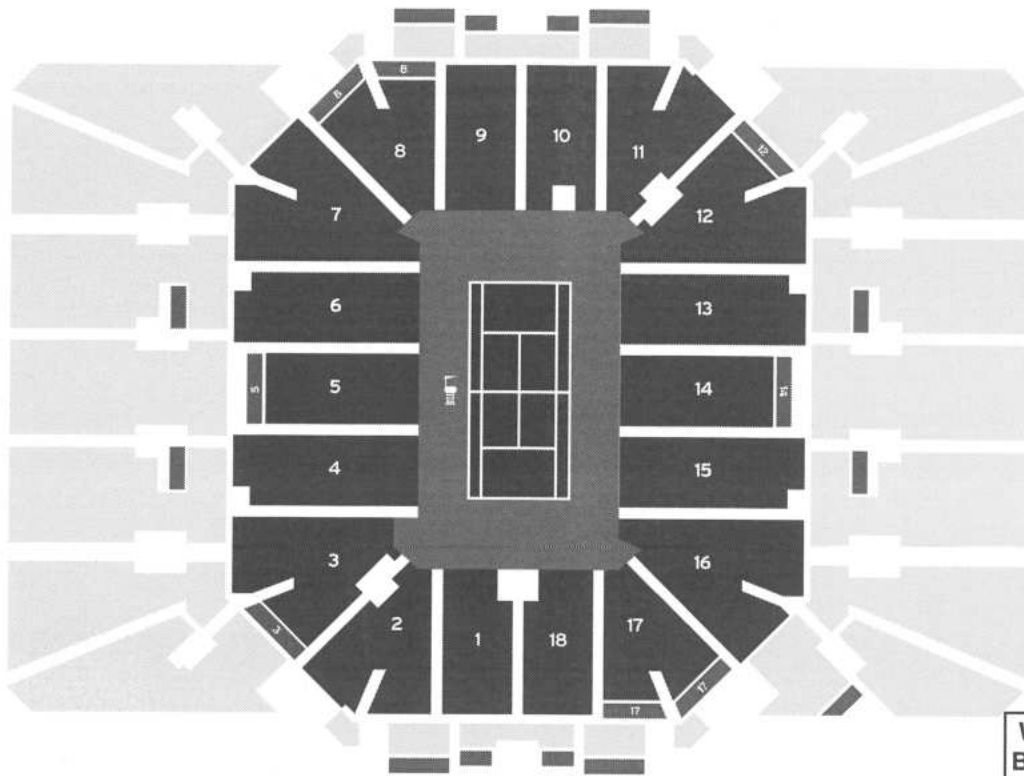

Louis Armstrong Stadium (with a retractable roof)

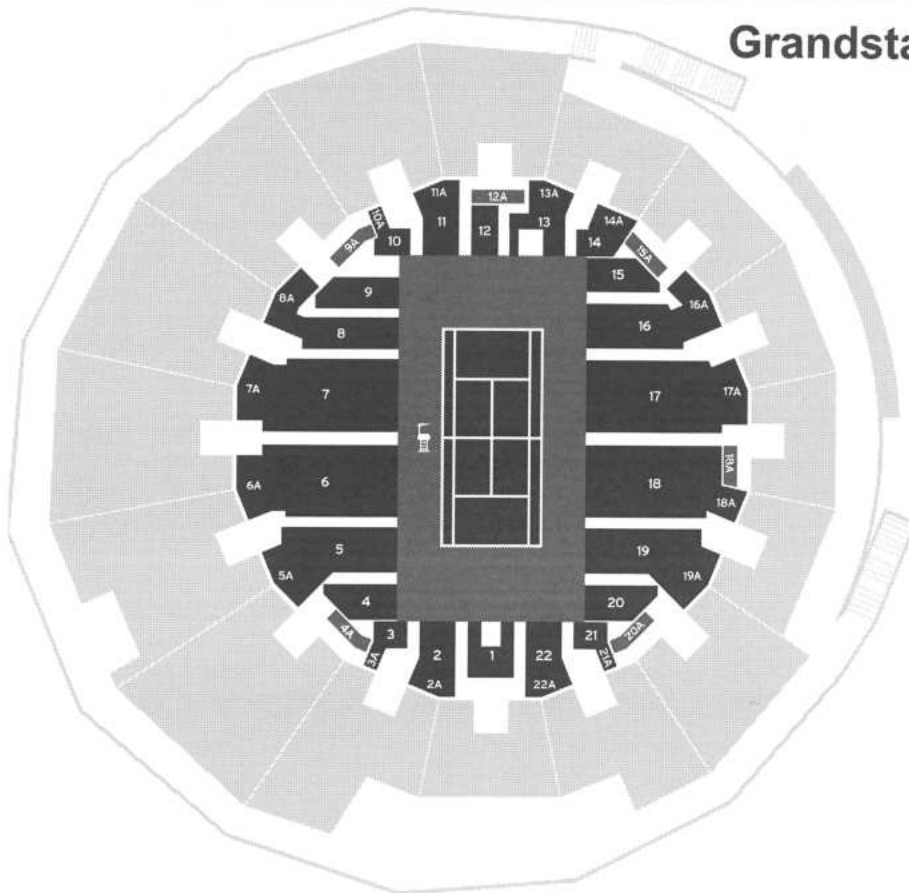

NYJTL POLICY FOR 2025 IN THE EVENT OF CANCELLATION OF A SESSION FOR RAIN

(Based on USTA's Inclement Weather Policy from 2024)

{Weather Insurance Available for purchase until 5pm, August 5, 2025}

- **PLEASE NOTE FOR 2025:** The below provisions regarding Sessions #1, 3, 5, 7, 9, 11, 13 (session 13 added in 2025) for Grandstand Stadium ticket holders, apply for any Session cancelled due to the rain. Insurance for Ashe and Armstrong stadiums is not relevant since the stadiums have a retractable roof.

NYJTL is a public charity and makes tickets available on a session-by-session basis to raise money for its charitable programs. This entitles the purchaser/donor to a charitable deduction for the difference between the cost of the tickets and the total amount paid. There is no refund of the donation portion, as that would negate its tax status as a donation. Tickets provided by NYJTL are virtually entirely from full series subscriptions, either owned directly by NYJTL or provided to NYJTL by the owner. Other than purchasing a sponsorship, hospitality package or a subscription directly from the USTA, this is the best way to obtain high quality seats, and the only way to ensure continued availability year after year. NYJTL will pass along to its purchaser/donors USTA cancellation policies and benefits. *Those benefits do not apply to Subscription Box, Series and Luxury Suite ticket holders.*
