□PLEASE NOTE FOR 2023: The below provisions regarding Sessions #1 through #20 for Arthur Ashe Stadium ticket holders & currently Sessions #1 through #13, and #15 for Louis Armstrong Stadium ticket holders, apply for any Session cancelled due to the unavailability of the retractable roof.

NYJTL is a public charity and makes tickets available on a session-by-session basis to raise money for its charitable programs. This entitles the purchaser/donor to a charitable deduction for the difference between the cost of the tickets and the total amount paid. There is no refund of the donation portion, as that would negate its tax status as a donation. Tickets provided by NYJTL are virtually entirely from full series subscriptions, either owned directly by NYJTL or provided to NYJTL by the owner.
