2020 US Open Championship Tickets to Benefit NYJTL

Dear Friend of NYJTL:

Thank you for your support of the 2019 US Open Ticket Benefit for New York Junior Tennis & Learning. All of the net proceeds will support comprehensive after school programs that incorporate tennis, academic enrichment, healthy living and character development for tens of thousands of inner-city youth. We want to thank and acknowledge the USTA for allowing us the privilege of using US Open tickets to raise these much needed funds.

We will start to allocate seats for the **2020 US Open** on February 4, 2020. Enclosed are our 2020 prices and applications. If you wish to order, please complete the application and return it to us with a 50% deposit. The balance will be due March 6, 2020. If you would like an extended payment schedule, please contact Skip or Alex.

Previous year's purchasers will receive preference to renew if their application and deposit are received by February 3, 2020, unless such renewal is impossible due to the schedule changes or such renewal is not in the best interest of NYJTL's overall fundraising goals. Criteria include: a) previous year purchaser; b) previous support of NYJTL's other charitable events and programs; c) ticket availability.

Also please note:

- 1. 2020 changes/updates:
 - a) The 2020 Open will again feature the new Louis Armstrong Stadium with a retractable roof. The day sessions will start at 11am for the first 9 days of the tournament and the night sessions will start at 7pm each evening, for the first six days of the tournament (through Saturday, 9/5 night).
 - b) In Ashe Stadium, the matches will once again start at 12 noon and the night matches will also start at 7pm.
 - c) US Open will again be a traditional Grand Slam 14 day event: Monday, August 31 Sunday, September 13.
 - Women's Semifinals Thursday evening, September 10; Men's Semifinals Friday, September 11;
 Women's Final Saturday, September 12; Men's Final Sunday, September 13.
- Should the USTA make any changes prior to the 2020 Open to our present understanding of the 2020 schedule and pricing
 that would significantly change the value of a particular session, you may change your request without penalty or cancel and
 receive a full refund. Also, NYJTL reserves its right to change its prices to reflect the changed value.
- 3. The terminology for seats in Ashe Stadium in order of distance from the court is as follows: courtside boxes, luxury suites, loge boxes, and promenade seats.
- 4. We continue to offer rain insurance for tickets in Ashe Stadium, Armstrong Stadium and the Grandstand Stadium since NYJTL does not take these risks, and the donor does. Although Ashe Stadium and the Armstrong Stadium have retractable roofs, it is indicated on the USTA's weather policy that should the retractable roof(s) become unavailable, then their inclement weather policy would be put into effect for sessions 1-20. You should estimate that the coverage and cost will be similar to the 2019 costs. More detailed information may be found on the attached yellow sheet which describes 2019 coverage. Since coverage is keyed to the USTA cancellation policy, we will not finalize coverage until the USTA publishes its 2020 policy.
- The difference between NYJTL's cost of the ticket and our price is a charitable contribution to NYJTL.

We are greatly appreciative of your support. 





Louis Armstrong Stadium (with a retractable roof)



NYJTL POLICY FOR 2020 IN THE EVENT OF CANCELLATION OF A SESSION FOR RAIN

{Weather Insurance Available for purchase until 5pm, August 13, 2020}

□ PLEASE NOTE FOR 2020: The below provisions regarding Sessions #1 through #20 for Arthur Ashe Stadium ticket holders & currently Sessions #1 through #13, #15 and #17 for Louis Armstrong Stadium ticket holders, apply for any Session cancelled due to the unavailability of the retractable roof.

NYJTL is a public charity and makes tickets available on a session-by-session basis to raise money for its charitable programs. This entitles the purchaser/donor to a charitable deduction for the difference between the cost of the tickets and the total amount and increase is no refund of the donation portion, as that would negate its tax status as a donation. Tickets provided by NYJTL are virtually entirely from full series subscriptions, either owned directly by NYJTL or provided to NYJTL by the owner. Other than purchasing a sponsorship, hospitality package or a subscription directly from the USTA, this is the best way to obtain high quality seats, and the only way to ensure continued availability year after year.
